MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE  
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)  
(LAVENTILLE STEELBAND FESTIVAL CELEBRATIONS)  
ORDER, 2023

1. This Order may be cited as the Traffic Restriction (Temporary Provisions) (Laventille Steelband Festival Celebrations) Order, 2023. Citation
2. This Order has effect between the hours of 2.00 p.m. on Saturday 5th August, 2023 to 1.00 a.m. on Sunday 6th August, 2023. Duration
3. Parking is prohibited on the following roads: Parking prohibited
  - (a) Eastern Main Road, between Morvant Junction and Old St. Joseph Road;
  - (b) Leotaud Street; and
  - (c) Old St. Joseph Road.
4. Motorists are prohibited from driving on the Eastern Main Road between Morvant Junction and Old St. Joseph Road. Vehicular traffic prohibited
5. Vehicular traffic shall proceed in both directions along the Old St. Joseph Road between Readymix Street and Leotaud Street. Two-way traffic
6. (1) Motorist proceeding west along the Eastern Main Road shall upon reaching Morvant Junction turn south onto the Beetham Highway Extension, west onto the Priority Bus Route and exit south onto Abattoir Road. Traffic routes  
(2) Motorist proceeding east along the Eastern Main Road shall divert onto the Old St. Joseph Road and re-enter the Eastern Main Road *via* Leotaud Street and proceed east.
7. Notwithstanding the Classification of Highways Order, motorists may proceed west along the westbound carriageway of the Priority Bus Route between the junction of the Beetham Highway Extension and Priority Bus Route and Abattoir Road only. Priority Bus Route G.N. No. 51 of 1975
