MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(REPUBLIC OF TRINIDAD AND TOBAGO SIXTY-FIRST
ANNIVERSARY OF INDEPENDENCE CELEBRATIONS
REHEARSAL) ORDER, 2023

1. This Order may be cited as the Traffic Restriction (Temporary ^{Citation}
Provisions) (Republic of Trinidad and Tobago Sixty-First Anniversary of
Independence Celebrations Rehearsal) Order, 2023.

2. This Order shall have effect between the hours of 5.00 a.m. and ^{Duration}
1.00 p.m. on Wednesday 23rd August, 2023.

3. A driver of a vehicle is prohibited from parking on the following ^{Parking}
roads: _{prohibited}

- (a) Serpentine Road, between Serpentine Place and Western Main Road;
- (b) St. Clair Avenue, between Elizabeth Street and Roxy Roundabout;
- (c) Hayes Street, between Elizabeth Street and Serpentine Road;
- (d) Kavanagh Street, between St. Clair Avenue and Tragarete Road; and
- (e) Tragarete Road, between Kavanagh Street and Western Main Road.

4. The following roads are closed to vehicular traffic:

^{Roads closed}

- (a) from 6.00 a.m. to 12.00 noon—
 - (i) Serpentine Road, between Serpentine Place and Western Main Road; and
 - (ii) Hayes Street, between Elizabeth Street and Serpentine Road; and

(b) from 7.00 a.m. to 12.00 noon on—

- (i) Western Main Road, from Roxy Roundabout to Long Circular Road;
- (ii) Havelock Street, between St. Clair Avenue and Tragarete Road;
- (iii) Broome Street, between St. Clair Avenue and Tragarete Road;
- (iv) Kavanagh Street, between St. Clair Avenue and Tragarete Road; and
- (v) Serpentine Road, between Western Main Road and Flood Street.

5. Without prejudice to any other liability incurred by the commission of a traffic violation, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
