THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(CARIBBEAN PREMIER LEAGUE T20) ORDER, 2024

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Caribbean Premier League T20) Order, 2024.

2. This Order shall have effect from Wednesday 18th September, Duration 2024 to Saturday 28th September, 2024.

4. A driver shall not park his motor vehicle on—

- (a) Tragarete Road, between Broome Street and Gray Street;
- (b) Hayes Street, between St. Clair Avenue and Tragarete Road;
- (c) St. Clair Avenue, between Broome Street and Gray Street;
- (d) Elizabeth Street, between St. Clair Avenue and Tragarete Road; and
- (e) Sweet Briar Road, between Elizabeth Street and Gray Street.

5. A driver shall not drive or park his motor vehicle on—

- (a) Elizabeth Street, between St. Clair Avenue and Tragarete Road; and
- (b) Sweet Briar Road, between Elizabeth Street and Alexandra Street.

 - (c) 4.00 p.m. on Friday 27th September, 2024 to 1.00 a.m. on Saturday 28th September, 2024.

7. A driver shall not drive or park his motor vehicle on—
- (a) Brian Lara Boulevard; and
 - (b) the southbound exit ramp (Princes Town exit) Off the Sir Solomon Hochoy Highway onto Tarouba Link Road.

8. A driver shall not park his motor vehicle on—
- (a) Gasparillo Bypass Road;
 - (b) Palmyra Agricultural Road;
 - (c) Brian Lara Cricket Academy Access Road;
 - (d) Tarouba Link Road; and
 - (e) the northbound shoulder and southbound shoulder of the Sir Solomon Hochoy Highway between Corinth and Gasparillo overpass.

One-way

9. A driver shall proceed along Gasparillo Bypass Road, between the Sir Solomon Hochoy Highway and Palmyra Agricultural Road, in an easterly direction only.

10. Without prejudice to any other liability incurred by the commission of a traffic violation, vehicles found parked in contravention of this Order may be removed by the police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
