- 9:45 a.m. The Honourable The Chief Justice and Mrs. Denise Rodriguez-Archie arrive and are met by the Very Rev. Dean Colin Sampson.
- 9:46 a.m. Attorneys-at-law (in reverse order of seniority, the most junior first), followed by the Magistrates (in reverse order of seniority), Masters of the High Court and the Honourable Judges of the Supreme Court (in reverse order of seniority), enter the Cathedral and take their seats.
- 9:50 a.m. The Honourable Prime Minister and Dr. Gregory Bissessar arrive and are accompanied to their seats by The Honourable The Chief Justice and Mrs. Denise Rodriguez-Archie and by the Very Reverend Dean Colin Sampson.
- 9:55 a.m. Their Excellencies The President and Dr. Jean Ramjohn-Richards arrive and are accompanied to their seats by The Honourable The Chief Justice and Mrs. Denise Rodriguez-Archie and by the Very Reverend Dean Colin Sampson.

- 11:10 a.m. The Honourable Judges of the Supreme Court and the Masters of the High Court proceed to their chambers. Members of the legal profession and guests take up positions or seats on the steps of the Hall of Justice, facing Knox Street, and await the inspection of the Guard of Honour.
- 11:20 a.m. The Honourable Judges of the Supreme Court and the Masters of the High Court, led by The Honourable The Chief Justice, assemble on the steps of the Hall of Justice facing Knox Street. The Honourable The Chief Justice inspects the Guard of Honour.
- 11:30 a.m. The Honourable The Chief Justice, the Honourable Judges of the Supreme Court and the Masters of the High Court assemble on the steps of the Hall of Justice, facing Abercromby Street, where The Honourable The Chief Justice takes the salute by the Guard of Honour.
- 11:50 a.m. Members of the legal profession and guests take their seats in the Convocation Hall of the Hall of Justice.
- 12:00 noon The Honourable The Chief Justice, the Honourable Judges of the Supreme Court and Masters of the High Court take their seats on the dais in the Convocation Hall. The Honourable The Chief Justice addresses the gathering, opens the 2012-2013 Law Term and adjourns Court. The Honourable The Chief Justice, the Honourable Judges and the Masters of the Supreme Court rise.
